Foster Families Give Cats a Chance



Sasha Fierce came to Cat Welfare on June 12th and was immediately taken to MedVet because someone had seen her get hit by a car, and it was obvious that there was damage to her back legs. The veterinary staff at MedVet discovered the femur on her rear right leg was fractured, as was the femoral head of her left leg. The kitten was given pain medication and brought back to the shelter so Dr. Nelson of Oak Creek Veterinary Hospital could evaluate her for surgery.

Dr. Nelson felt confident in his ability to help her, and surgery was performed to place pins in her tiny legs to help her bones fuse back together. The surgery took nearly three hours, and little Sasha Fierce was kept at the practice for evaluation for 24 hours. Upon her return to Cat Welfare, she was placed in the home of loving foster parents RoseAnn Ballangee and Nancy Flanagan. They cleaned her up after every trip to the litter box until she was strong enough to go without trouble, and they have been rewarded with a happy kitten who loves to be petted and held and will happily lounge on the couch to watch TV in the evenings. The spunky, sweet Sasha is expected to be available for adoption sometime in August.

Have you ever thought about becoming a foster parent for kittens and cats like Sasha Fierce who need some extra care before they're ready for adoption? Cat Welfare will hold a meeting for potential foster families from 5 to 7 p.m. Thursday, August 25, at Panera Bread, 4519 N. High St. in Clintonville.

The meeting will provide more information about the program, as well as training for existing foster families.

Petfinder Matches Cats with Forever Homes

Volunteers Julie Karovics and Linda Schellkopf began their work to put Cat Welfare's kitties on Petfinder in June 2010. They hoped that increasing the visibility of the shelter cats would result in more adoptions—and it has! They started relatively small, featuring only adoptable 20 cats, but as the program has seen some success, they have slowly increased the number to between 45 and 60.

Julie and Linda have received many positive comments about the Petfinder portion of www.catwelfareohio. com, which can be found at the bottom of the home page. Many visitors have even reported "shopping" online before making the trip to the shelter or explained that stumbling upon one of our cats on www.petfinder.com brought them into the shelter for a visit. Some potential adopters even arrive with printouts and lists of the cats they want to meet. An average of 12 Cat Welfare cats posted on Petfinder get adopted every month, which keeps Julie and Linda busy adding new kitty faces to the list!
